PRESIDENTIAL EVALUATION COMMITTEE

The Presidential Evaluation Report was presented by Julie Pokela, Chair, Presidential Evaluation Committee.

Trustee Pokela explained the cycle of the President's Evaluation. She indicated every third year there is a comprehensive evaluation process, and this year we are in year two. The President's evaluation will be based on performance with the Strategic Planning goals, and performance benchmarks from Department of Higher Education. A survey link will be emailed to the Board, key stakeholders and direct reports requesting feedback. The President's Evaluation will be brought back to the Board at the June meeting.

REPORT OF THE CHAIR

Aside from several phone calls with President Royal, Chair Gilbert also participated on:

- May 1st Attorney General Maura Healey visited HCC. The Attorney General was provided with a tour led by Trustee Woods. The Attorney General spoke to our students, faculty and staff regarding issues our students are currently facing with regards to homelessness, food insecurities, the opioid crisis, etc.
- May 9th HCC Foundation's Annual Scholarship Reception. Chair Gilbert thanked Amanda Sbriscia and her team for a successful event.
- May 17th Met with President Royal to set the agenda for today's meeting.
- May 22nd Attended the Honors & Awards Night Reception.
- Reviewed and signed the engagement letter from O'Connor and Drew.

PRESIDENT'S REPORT

General Updates

President Royal acknowledged Trustee Woods for her high academic achievement and for graduating this year. She thanked her for her service as the Student Trustee and her work with the Student Senate.

President Royal began the Strategic Plan In-Depth topic by talking about the state's budget and how it allocates funding for community college students and the disparity in state funding.

Strategic Plan In-Depth Topic was provided by Amanda Sbriscia, Vice President of Institutional Advancement & Executive Director HCC Foundation

Today's presentation focused on supporting students through private sources and the role of the HCC Foundation and scholarships.

According to HCC Fall 2018 data, 79% of HCC students receive some form of financial aid. An HCC education, by comparison, is one of the most affordable in the Commonwealth, yet, 79% of students must seek out grants and loans. HCC is focused on implementing a Team-Based Case Management model within the Strategic Plan, where every incoming student is assigned a support team to guide them through the student lifecycle, directing them to resources and services.

The HCC Foundation mission is to provide financial support for the programs, activities, and students of Holyoke Community College.

The HCC Foundation accomplishes this in three broad areas:

- Facilities: The Kittredge Center for Business & Workforce Development, funded in part by a \$1 million gift from HCC alumnus Michael Kittredge; the Center for Health Education, which was supported in part by a fundraising campaign titled "Building Healthy Communities," and the HCC MGM Culinary Arts Institute.
- Programs & Activities: Are funded through grant dollars. Resource Development is part of the Advancement operation and works closely with various departments to make grant dollars reality.
- The Foundation: Provides programmatic and equipment support throughout the year for upgraded computers, piano tuning, etc.
- Students: this year, 7 new scholarships were established with the Foundation.

Landscape: What We Know

- State Funding Declines
 - · 30-year disinvestment in public higher education
- The HCC Student
 - 57% part-time; 43% full-time
 - From Western Mass. county with lowest median family income (Hampden: \$62,350)
 - More responsible for financially assisting the family (working to supplement household income vs. working to pay out-of-pocket school expenses)

How are students funding their education?

Avg. Tuition & Required Fees: \$4.902

- In 2016-2017, 79% of HCC students received some form of financial aid
- · Trends:
 - Increase in external book advances
 - Withdraws due to financial aid reductions

Success looks like: Students new to HCC are assigned a support team at the point of admission. This team is responsible for assisting assigned students through the student lifecycle, including major and course selection, financial aid, and referral to appropriate support services. Students receive a personalized approach, feel connected and supported.

Evolving Role of Financial Aid: Counselor

- Schedules personal appointments for students due to increased need for counseling assistance
- Responds to complex financial situations and family dynamics
- Disburses financial aid earlier to eliminate emergency needs
- · Demystifies financial aid with weekly "Loan Chat"



Trustee Plotkin thanked Dr. Senie and Dr. Dhankher for their time and work implementing and leading the work of the Strategic Plan.
