- IV. Committee Rports
 - A. Equity Committee Trustee Johnson provided an update on the Committee's work since the last meeting. The Committee is assessing the training series provided over the past academic year, and will be looking for feedback from fellow trustees. The Committee is also working on securing a speaker for the Fall semester; and continuing their work with the EDI Council to work collaboratively.
 - B. Audit and Finance Committee Trustee Epstein provided an update of the work of the Committee to review the investment portfolio; especially with Eaton Vance taking on a larger portion of the College's investments.
 - C. Nomination and Presidential Evaluation Committee Interim Chair Smith updated the Board on the work of Elizabeth Denny, who is an outside consultant, that has helped with the Presidential Evaluation process for the last several years. From the Nominating Committee, the work is ongoing and hope to hear about some vacancies soon. The Committee continues to generate a list of interested people for future vacancies.
 - D. HCC Foundation Board Vice President Sbriscia will be presenting later in the meeting, that includes some of the work the Foundation had done over the past year. The Foundation just concluded their final strategic alignment session, which confirms the mission, vision, strategic values and purpose. More information will be provided in the coming months.
 - E. By Laws and Governance Trustee Vidal will connect with the Chair of each Committee to gather information regarding brief descriptions of purpose to include in the handbook. The work of the Handbook is ongoing. The Committee would like the website updated with Trustee pictures and a short biography. And finally, the Committee will work on a Trustees' competencies sheet to gather the strengths of each Board member.

VII. President's Report

President Timmons updated the board on the recentHCC Foundation's Annual Scholarship Reception awarding \$335,000 in scholarships to our students. This amount represents 388 scholarships to 323 incoming, current and transferring HCC students. He thanked the Foundation for their partnerhsip in removing barriers to our students' success.

The College received an award notification from the Workforce Competitiveness Trust Fund for approximately \$1.5 million in grant funds for continuing and enhancing our training and placement program.

The Student Records Office launched a pilot review of active records for the completion of stackable certificates, also know as Operation Completion Review Iniative. The iniative targets students who have either completed or are currently enrolled in the requirements of a certificate. The purpose of the project is to steamline the credentialing process, demostrates our commitment to supporting student success, and enables students to earn additional qualifications to improve competitivess in the job market or possible career advancement. This year, we have 90 students who were eligible to add an additional credential to their record.

President Timmons was honored to moderate the Tech Foundry's Visionary Workforce Development Discussion Panel as part of celebrating ten years of workforce development, innovation and impact. The panel included, CEO, Jay Ash, Mass Competitive Partnership; Meghan Martinez, Director of Cyber Range Programs, Cybertrust MA; and Jason Pacheco, Director of Workforce Planning, Analytics and Compesentation, Baystate Health. President Timmons highlighted our student, Joseph Black, an environmental science major and HCC STEM Scholar, who has been selected for the Newman Civic Fellowship for the 2024-25 academic year. This is a national award that recognizes leadership potential and a commitment to positive change in the community. He is one of three community college students selected in Massachusetts.

President Timmons thanked the the Stop and Shop leadership team for selecting Holyoke Community College's Food Pantry as the June 2024 Nonprofit Partner for the Bloomin' 4 Good Program. HCC will receive a \$1 donation for every specially marked \$10,99 Bloomin' 4 Good bouqet sold thorugh June 2024.


Catalyst for Change: Joseph Black, environmental science major
