Instructions for obtaining for obtaining a tax transcript.

A 2023 IRS Tax Return Transcript may be obtained through:

- Get Transcript Online
 - o Go to www.irs.gov
 - o Click "Get Your Tax Record."
 - o Click "Get Transcript Online." Make sure to request the "Return Transcript" and NOT the "Account Transcript."
 - o To use the Get Transcript Online tool, the user must have (1) access to a valid email address, (2) a text enabled mobile phone (pay-as-you-go plans cannot be used) in the user's name, and (3) specific financial account numbers (such as a credit card number or an account number for a home mortgage or auto loan). The transcript displays online upon successful completion of the IRS's two-step authentication.
- Get Transcript by Mail
 - o Go to www.irs.gov
 - o Click "Get Your Tax Record."
 - Click "Get Transcript by Mail." Make sure to request the "Return Transcript" and NOT the "Account Transcript."
 - The transcript is generally received within 10 business days from the IRS's receipt of the online request.
- Automated Telephone Request
 - Call 1-800-908-9946. The transcript is generally received within 10 business days from the IRS's receipt of the telephone request.
- Paper Request Form
 - IRS Form 4506T-EZ or IRS Form 4506-T. The transcript is generally received within 10 business days from the IRS's receipt of the paper request form.
